It is important that all the Chapters in your District be aware of the importance of this committee and ask them to discuss any Constitution and By-Laws or Ritualistic changes that they would like to submit for consideration by the Legislation and By-laws committee.

When a Chapter approves a recommendation for a change at a Chapter meeting, the proper form needs to be completed and submitted to the District Convention for consideration by the District Legislation Committee. If approved at the District level, the form is then submitted to the National Legislation Chairperson to be presented at the National Convention, Legislation Committee. This committee considers all requests for legislative changes, and if approved by this committee, the changes are presented to the convention body for a final decision.

The proper form for submitting these requests is enclosed. Each proposal requires a separate form. All recommendations for changes passed at your District Convention must be returned to me by the District Legislation Chairperson. The deadline date will be June 15, 2009.
